

## 2023 Dorothy Lane Market Health Fair Passport Giveaway Official Rules

### NO PURCHASE NECESSARY TO ENTER. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S LIKELIHOOD OF WINNING.

2023 Health Fair Passport Giveaway is sponsored by Dorothy Lane Market, Inc. Entries are accepted at the Health Fair at Dorothy Lane Market Springboro. Prize amounts vary.

**SWEEPSTAKES PERIOD:** The 2023 Health Fair Passport Giveaway begins 03/25/22 at 11 a.m. EST and ends 03/25/22 at 3 p.m. EST at participating Dorothy Lane Market Locations. All entries must be submitted within the above stated Health Fair entry period.

**ELIGIBILITY:** All legal residents of the United States ages eighteen (18) years or older are eligible to win the 2023 Health Fair Passport Giveaway with a valid entry. No purchase necessary. Sweepstakes is subject to all local, state and federal laws and regulations. ### WAYS TO ENTER:

(A) Paper forms will be available at Dorothy Lane Market Springboro at the entrance and mezzanine. All paper forms must be fully completed and submitted to the Dorothy Lane Market associate working the Health Fair before 3 p.m. EST on 03/25/2023 to be eligible for entry. Incomplete forms will not be submitted into the Door Prize drawing pool.

### PRIZE, APPROXIMATE RETAIL VALUE (ARV), ODDS OF WINNING, AND PUBLICITY

On 03/27/2023, entries from the complete pool of eligible Door Prize entries for each Door Prize basket will be randomly selected. Attempt to contact raffle winners will be made on 03/27/2023.
